EARLY FURNACE REPLACEMENT REBATE

Fuel Type	Minimum AFUE Requirements	Early Furnace Replacement Rebate
Natural Gas	95% with ECM	\$1,000
Propane	95% with ECM	\$1,000
Oil	86% with ECM	\$750

Customer Eligibility Requirements

- Applicants must be a residential customer of a Mass Save sponsor
- Municipal Electric customers must heat with natural gas provided by a participating Gas Utility
- Customer must request a Mass Save Home Energy Services Program Site Visit between **April 1, 2015 and August 31, 2015**, prior to replacing their boiler or furnace
- Equipment must be installed by **October 30, 2015**
- Completed Rebate Form and other relevant documentation must be submitted by **October 30, 2015**
- Fuel switching/conversion is NOT eligible for this offer
- Distribution change/conversion is **NOT** eligible for this offer
- At the time of the Site Visit, customer must have an existing, functional boiler (at least 30 years old) or furnace (at least 12 years old) that is fueled by natural gas, propane, or oil to be eligible for the replacement program
- Equipment must be installed in a 1-4 family home
- Customers receiving the Early Heating Equipment Replacement Rebate are NOT eligible for any other Mass Save or GasNetworks heating equipment rebates on installed equipment
